- 11. Letter(s) of recommendation from two former associate professors/professors or with similar qualifications

- 12. Resume (in Chinese or the taught language of your program)
- 13. Visa page (for applicants currently studying in a university in China)
- 14. Study certificate (for applicants currently studying in a university in China Please upload to the file entitled "other attachment".)
- 15. School transfer certificate or School withdrawal certificate (for applicants currently studying for degrees in a university in China Please upload to the file entitled "other attachment".)
- 16. Recommendation letter and academic transcript from your current university (for applicants currently studying in a university in China Please upload to the file entitled "other attachment".)
